Joe,

As requested, the review of those tanks at the marina area was completed (comments regarding PAHs in the other areas are pending).

The geologist's comments regarding his review of UST 202A and 202D area are that the permanent well non-detects for PAHs is not relevant due to their lack of proximity (60' +) to the USTs in question.

I re-read my March 30, 2016 comments regarding the workplan for these USTs. In that comment letter I'd stated (I added underline for prominence just now) "Sampling as proposed is approved. To clarify, however, it is assumed elevated levels of ground water contamination remain at UST 202D, and proposed sample located downgradient is for delineation purposes." Therefore, it was to be stipulated ground water contamination remained at the UST, which would render it ineligible for nfa.

Recommendations – install a permanent well at location immediately downgradient of UST 202D. Analyses required for VOs and SVOCs; SVOCs should be collected via low-flow.
