- 2. We request you disseminate this information to your installations. We are providing these enclosed MOU for your use in managing natural resources on your installations as appropriate. We fully encourage your use of these MOU as tools to enhance your ability to engage the workforce outside the Department of Defense in support of Integrated Natural Resources Management Plans (INRMPs). If you are unable to find funding for cooperative efforts, contact us for assistance. We will do our best to work with you to find a funding source.
- 3. I would like to direct your attention to one issue in reference 1a. Paragraph F.1.e. states DOD will... "Make available to the Service, to the extent practicable, existing information on fish, wildlife, and plant resources on military lands, including contaminant problems that may potentially affect natural resources." In most cases, installation contaminant information is publicly available through the Installation Restoration Program (IRP) and Ecological Risk Assessments.

  Management prescriptions in the INRMP should take contamination issues into account; however, it is not necessary to reproduce analyses in the INRMP.
- 4. The IRP is responsible for identifying contaminant releases, assessing impacts to the environment (including endangered species, migratory birds, and biotic communities), and developing

and selecting response actions when unacceptable risks to ecological receptors from release is likely. If signatory agencies have an interest in specific contamination issues, refer them to those publicly held documents.

# MEMORANDUM OF UNDERSTANDING BETWEEN THE DEPARTMENT OF DEFENSE AND THE U.S. FISH AND WILDLIFE SERVICE

FOR THE

ECOSYSTEM-BASED MANAGEMENT OF FISH, WILDLIFE AND PLANT RESOURCES
ON MILITARY LANDS

#### A. PREFACE

- 1. This Memorandum of Understanding (MOU) establishes a policy of cooperation and coordination between the Department of Defense (DoD) and the U.S. Fish and Wildlife Service (Service) for the effective and efficient management of fish, wildlife, and plant resources on military lands.
- 2. The DoD is responsible for managing approximately 25 million acres of land and waters while at the same time accomplishing its primary mission of national defense.
- 3. DoD lands and waters contain sensitive ecosystems, threatened and endangered species, migratory birds, forests, deserts, wetlands, coastal areas, and other resources.
- 4. The DoD, with the assistance of the Department of Interior, is responsible under the Sikes Act (16 U.S.C. 670a-670f, as amended) for carrying out programs and implementing management strategies to conserve and protect biological resources on its lands.
- 5. The DoD has a history of commitment to environmental security and the management and protection of the resources which have been entrusted to its stewardship.
- 6. The Service is responsible for managing the approximately 92 million acres of the National Wildlife Refuge system, and for administering the Endangered Species Act, the Migratory Bird Treaty Act of 1918, the Anadromous Fish Conservation Act, and other fish and wildlife statutes.
- 7. The Service desires to provide technical expertise to assist in the DoD's management of military lands. The Service also desires to coordinate management of its lands with conservation activities on nearby DoD lands and waters.

- 8. The DoD and the Service have a successful history of cooperation. Both parties desire to work effectively on cooperative projects concerning the management and protection of fish, wildlife, and plant resources on an ecosystem basis.
- 9. The Economy Act (31 U.S.C 1535 and 1536.) allows a Federal agency to enter into an agreement with another Federal agency for services, when those services can be rendered in a more convenient and cost effective manner by another Federal agency.
- 10. The DoD and the Service agree to work cooperatively in areas of mutual interest.

#### B. PURPOSE

The purpose of this MOU is to facilitate the effective and efficient protection and management of natural resources, including fish, wildlife, and plant resources, on an ecosystem basis on lands and waters controlled by the DoD.

#### C. BACKGROUND

The DoD and the Service have a long history of cooperation concerning the management of fish, wildlife and plant resources on military lands. Through the Sikes Act, the Service has coordinated on hundreds of fish and wildlife plans for DoD installations. Through a "Joint Agreement of Cooperation to Perpetuate North American Waterfowl Populations" (August 11, 1988), the DoD and the Service agreed to support the goals of the North American Waterfowl Management Plan (Plan) to protect, restore, and enhance wetland habitat to benefit breeding, migrating, and wintering waterfowl and other wetland species. That Agreement, which expired on September 30, 1992, focused on military land located in or near "Joint Venture" areas, that is, major wetland habitat areas identified in the Plan.

## D. <u>DEFINITION OF AN INTEGRATED NATURAL RESOURCES</u> <u>MANAGEMENT PLAN</u>

Integrated natural resources management plans (INRMPs) are plans for military installations based, to the maximum extent practicable, on ecosystem management principles and guidelines. INRMPs provide for the management of natural resources, including fish, wildlife, and plants, allow multipurpose uses of those resources, and provide public access necessary and appropriate for those uses, without any net loss in the capability of an installation to support its military mission. An INRMP shows the interrelationship of individual components of natural resources management (e.g., fish and wildlife, forestry, land management, and outdoor recreation.) to mission requirements and other land uses affecting an installation's natural resources.

## E. <u>PREPARATION OF INTEGRATED NATURAL RESOURCES</u> <u>MANAGEMENT PLANS (INRMPs)</u>

INRMPs may be prepared for military installations with cooperation and assistance of the Service. Areas in which the Service has expertise and may be of assistance include:

- 1. Protecting, managing, restoring, and conserving fish, wildlife, and plant resources and their habitats, to include inventorying and trends analysis for aquatic and terrestrial habitats;
- 2. Protecting candidate, threatened, and endangered species as specified in the Endangered Species Act, and in consultation with the Service, including coordinated protection and mitigation measures, methods and procedures for enhancing these species;
- 3. Protecting species specified in the Migratory Bird Treaty Act;
- 4 Implementing the Sikes Act;
- 5. Training DoD personnel in the management of natural resources and enforcement of Federal and State natural resources laws and regulations;
- 6. Providing, with the States, background information and guidance on criteria and procedures for hunting, fishing, and trapping permits, fees, access, and enforcement;
- 7. Advising on other outdoor recreational opportunities, including user fees and access, if appropriate;
- 8: Advising on the control of off-road recreational vehicles;
- 9. Advising on the promotion of recreational user ethics;
- 10. Providing guidance on sustainable public use of natural resources:
- 11. Advising the military services on present or proposed research;
- 12. Advising the military services on proposed policy issues;
- 13. Advising on natural resources damage assessments and other appropriate natural resources issues;

- 14. Investigating, consulting, and restoring, if necessary, fish and wildlife resources and their habitat affected by or potentially affected by contaminants and other hazards; and
- 15. Conducting inventories of wetlands, deepwater habitats, and other fish and wildlife habitats and preparing digital databases for use in geographic information analyses.

#### F. RESPONSIBILITIES

The DoD and the Service do mutually agree upon the following responsibilities:

- 1. The DoD will, subject to the availability of funds:
  - a. Provide to the Washington office of the Service by March 31 of each year, a list of installations that desire assistance with developing or updating INRMPs during the next fiscal year. All requests from installations and other management projects will be prioritized using the following criteria
    - (1) Projects related to the management of fish, wildlife and plant resources, to ensure compatibility with the military mission;
    - (2) Projects that best coordinate work with Service management priorities; and
    - (3) Joint projects that could be implemented to effectively use the principles and guidelines of ecosystem management.
  - b. Communicate the establishment of this MOU to all Military Departments, major commands, Regional Environmental Coordinator offices, and appropriate installations.
  - c. Forward all requests for funding through the chain of command.
  - d. Identify research requirements.
- e. Make available to the Service, to the extent practicable, existing information on fish, wildlife, and plant resources on military lands, including contaminant problems that may potentially affect natural resources.
- 2. The Service will, subject to the availability of funding, and upon the request of the DoD:

- a. Develop a regional work plan for military installations based on personnel workload considerations.
- b. Coordinate with appropriate Federal and State agencies, military representatives, and local private conservation organizations to identify potential natural resource restoration, conservation, rehabilitation and management projects and relevant joint enforcement activities on selected DoD lands.
- c. Participate in developing or updating INRMPs and activities for selected installations, as requested by DoD.
- d. Identify and develop a list of those military installations which are in close proximity to a national wildlife refuge. Where appropriate, participate in the development and implementation of coordinated management plans for those installations and refuges.
- e. Identify partnership opportunities with the DoD, and develop these opportunities for natural resources work conducted on military installations.
- f. Coordinate with and obtain approval from appropriate DoD officials prior to initiating activities other than law enforcement investigations on DoD installations.
- g. Communicate the establishment of this MOU to each Service Regional Office, and to each appropriate field station, including each refuge in close proximity to a military installation.
- h. Share with the military services, current and proposed research efforts.
- i. Expeditiously provide comments on newly developed or updated INRMPs.
- j. Promote technical assistance regarding the suitability of any areas identified by DoD as potentially having environmental contaminant problems, including advice on restoration activities, as appropriate, that may affect natural resources.
- k. Provide law enforcement support to protect and to conserve fish, wildlife and plant resources on DoD installations that fall within the authority and jurisdiction of the Service.
- 3. Furthermore, both parties agree that accomplishment of the purposes and objectives of this MOU are of mutual benefit, and any costs incurred by either party,

except for costs associated with projects specified in subagreements to this MOU, shall be borne by the parties individually. The signatory parties agree and understand that this MOU by either party is dependent upon lawful appropriation, availability, and allocation of funds by proper authorities. Nothing herein contained shall be construed as limiting or affecting in any way the vested or delegated authority of the Department of Defense or the U.S. Fish and Wildlife Service.

#### G. EVALUATION

The parties to this MOU or their designated representatives shall meet each December to review activities associated with this MOU, to share information specified in the MOU, and to establish a schedule of work for the coming year. Costs and benefits will be evaluated to ensure that the purposes of the MOU are being achieved, and to determine future efforts.

#### H. <u>DELEGATION AND ADMINISTRATION</u>

- 1. Authorized representatives of the DoD and the Service may execute subagreements within the scope of this MOU, if such subagreements comply with the requirements of the Economy Act and the Sikes Act.
  - 2. Expenditures under this MOU shall be determined by said subagreements.
- 3. Each said subagreement shall include a proposal from the initiator that identifies goals and objectives, study design and methods for work to be accomplished, and an estimated budget. When the scope of work, budget, payment schedule, and other terms and conditions are mutually agreed upon, a subagreement shall be issued by the appropriate contracting officer to duly obligate funds.
- 4. Any subagreement negotiated under authority of this MOU will remain in full force and effect, unless and until modified or terminated by local signatory parties, per terms of said subagreement.
- 5. Service efforts in implementing the projects specified in subagreements shall be reimbursed through an Economy Act order subject to the head of the ordering agency or unit deciding the order is in the best interest of the United States Government and the head of the agency deciding the goods or services cannot be provided as conveniently or cheaply by a commercial enterprise.

#### J. <u>MODIFICATION AND TERMINATION</u>

This MOU may be modified only by mutual agreement in writing and signed by both parties. This MOU will be reviewed after five years. Any modifications will require new signatures by both parties. This MOU may be terminated by either of the participating parties provided that 45 days notice, in writing, is given to the other party.

#### K. <u>IMPLEMENTATION</u>

This MOU becomes effective when signed by both parties.

#### MEMORANDUM OF UNDERSTANDING

#### BETWEEN

#### THE DEPARTMENT OF DEFENSE

#### AND

#### DUCKS UNLIMITED, INC.

#### I. BACKGROUND

This Memorandum of Understanding (MOU) is made and entered into between the Department of Defense ("DoD") and Ducks Unlimited, Inc. ("DU").

#### II. <u>AUTHORITY</u>

The parties enter this MOU under the provisions of the Sikes Act (16 U.S.C. 670a-670f, as amended), the Department of Defense Appropriations Act, 1991 (Operations and Maintenance, Defense-wide) (Public Law 101-511, Section 8120), and the Department of Defense Appropriations Act, 1994 (Operations and Maintenance, Defense-wide) (Public Law 103-139).

#### III. PURPOSE

The purposes of this MOU are to provide a foundation for cooperative development of selected wetlands and associated uplands administered by or under the jurisdiction of the DoD in order to maintain and increase waterfowl populations and to fulfill the objectives of the North American Waterfowl Management Plan, within the context of DoD's environmental security and military missions.

#### IV. PREAMBLE

WHEREAS, the DoD, in accomplishing its national defense mission, which includes military training and operations, is responsible for approximately 25 million acres of federal lands; and,

WHEREAS, the DoD is responsible for managing and protecting ecologically significant areas of such federal lands; and,

WHEREAS, the DoD has a history of commitment to environmental security and the management of resources that have been entrusted to its stewardship; and,

WHEREAS, the DoD has adopted ecosystem management and biodiversity conservation as its approach to natural resources stewardship; and,

WHEREAS, the DoD has a responsibility to reduce bird aircraft strike hazards (BASH) that may cause in-flight mishaps; and

WHEREAS, DoD managed lands covered under this MOU do not include Civil Works lands; and,

WHEREAS, the DoD desires to use the expertise of DU, an international non-profit organization that operates in the 50 states, U.S. territories, and with in-country partner organizations; and,

WHEREAS, DU cooperates with other land managing entities, governmental and non-governmental organizations to accomplish wetlands conservation and waterfowl habitat management as recognized methods to effectively fulfill certain mandates and regulations; and

WHEREAS, the primary mission of DU is to fulfill the annual life cycle needs of North American waterfowl by protecting, enhancing, restoring and managing important wetlands and associated uplands; and,

WHEREAS, the DoD and DU have agreed to work together for the purpose of cooperatively developing, restoring and enhancing wetlands and waterfowl habitat in fulfillment of the goals and objectives of the North American Waterfowl Management Plan.

#### V. <u>RESPONSIBILITIES</u>

NOW THEREFORE, the Department of Defense and Ducks Unlimited agree to work cooperatively in areas of mutual interest, as identified below.

- A. The Department of Defense will, via the chain of command, and under the terms of appropriate separate subagreements to this MOU:
- 1. Communicate the establishment of this MOU to all Military Departments, major commands, field operating agencies, and military installations.
- 2. Identify a point of contact for coordination of DU activities at the Office of the Deputy Under Secretary of Defense for Environmental Security.
- 3. Make available to DU, to the extent legal and practicable, existing information on waterfowl management on military lands.

- 4. Identify all BASH-related hazards of proposed activities or projects to be performed by DU.
- 5. Provide access to DU to military lands to further the purposes of this MOU, including the right of access for DU studies, and the right of access for construction, maintenance and inspection of DoD waterfowl habitat restoration and enhancement projects. Such access will be subject to applicable Federal laws, regulations and comprehensive management plans for the affected area, if any, will be consistent with safety and security consideration and compatible with military operations, and will be subject to approval by the Commander of the DoD installation.
- 6. Screen appropriate proposed wetlands project proposals and existing projects for possible implementation as partnership initiatives with the DU, and undertake joint planning on selected sites.
- 7. Provide DU with appropriate background information, when required, including, but not limited to site specific natural resources management plans.
  - 8. Provide appropriate on-site recognition of DU involvement.
- B. Ducks Unlimited will, subject to the availability of resources, and under the terms of separately funded subagreements to this MOU:
- 1. Communicate the establishment of the MOU and method of implementation to all DU offices.
- 2. Identify a DU point of contact to serve as coordinator for cooperative actions with the Military Departments.
- 3. Annually review potential DoD projects for waterfowl habitat restoration and enhancement and make the final determination on which proposals, if any, will be cost-shared by DU.
- 4. Recognize the potential hazards of waterfowl to aircraft and, when such hazards are identified, make alternative proposals with no BASH conflicts.
- 5. Provide assistance for the implementation of agreed upon projects which have been approved by appropriate DoD and DU officials and, where applicable, cooperating partner organizations.
- 6. Provide advice, biological review and engineering expertise on wetland areas selected for cooperative enhancement, which have been approved by appropriate DoD and DU officials, and where applicable, cooperating partner organizations.

FURTHERMORE, both parties mutually agree that accomplishment of the purposes and objectives of this MOU are of mutual concern and any costs incurred by either party shall be on a nonreimbursable basis. The signatory parties agree and understand that this MOU does not constitute a commitment of resources, and that performance under this MOU by either party is dependent upon lawful appropriation, availability, and allocation of resources by proper authorities. Nothing herein shall impede the parties from using other mechanisms for cooperating to accomplish the purposes set out above.

#### VI. GENERAL PRINCIPLES

- 1. Nothing in this MOU shall obligate any party herein to any present or future expenditure of funds.
- 2. This MOU is intended only to improve cooperation between the DoD and DU, and is not intended to create any right or benefit, substantive or procedural, enforceable at law by any party against the United States, its agencies, its officers, or any person.
- The parties of this MOU or their designated representatives shall meet annually to review activities associated with this MOU.
- 4. This MOU may be modified or amended only by mutual agreement of the parties in writing and signed by each of the parties hereto.
- 5. Consistent with the provisions of the 1994 Defense Appropriations Act (P.L. 103-139, 107 Stat. 1422), contracting officers within the Military Departments may, consistent with the policies of their department and the Department of Defense, negotiate and enter into subagreements within the scope of this MOU. Each subagreement shall meet the requirements of the DoD Grants Regulation.
- 6. Expenditures under this MOU shall be determined by said specific subagreements, entered into at the Headquarters, command, or installation level.
- 7. Each said subagreement shall include a proposal that identifies goals and objectives, design, and methods for work to be accomplished, and an estimated budget. When the scope of work, budget, and payment schedule are mutually agreed upon, a subagreement shall be executed by the appropriate contracting officer to duly obligate appropriated funds to implement the purposes of this MOU.
- 8. Any subagreement negotiated under authority of this MOU will remain in full force and effect, unless and until modified or terminated by local signatory parties, per the terms of said subagreement.
- 9. Nothing herein contained shall be construed as limiting or affecting in any way the vested or delegated authority of the Department of Defense.

10. Separate funding subagreements for each installation are not required under the terms of this MOU, but may be required to meet internal requirements of a particular Military Service or installation.

#### VII. MODIFICATION AND TERMINATION

This MOU shall remain in full force for ten years or until terminated by any of the signatories to the MOU, provided that 45 days written notice is given to each party; however, sufficient attempt should be made to modify, rather than to terminate, the MOU. Ten years after signature by all parties, this MOU shall be reviewed and considered for renewal. Signatures must be obtained from all parties to fully execute the renewal.

An installation commander or appropriate representative of DU may unilaterally withdraw their support for cooperative activities at a particular installation. Withdrawal would occur 30 days after written notification is delivered to the installation commander or to DU.

#### VIII. <u>IMPLEMENTATION</u>

This MOU becomes effective when signed by all parties.
